- Explain the basic stages of a divorce case and the role of paralegal at each stage, as applicable.
- Define the role of the paralegal in a typical family law case.
- Define the essential family law terminology and concepts, and can accurately define and apply these concepts.
- Discuss the ethical obligations of the paralegal and attorney when relating to the family law client.
- Discuss the principles of family law, and communicate the guiding principles of working with family law cases.

Unit II Case Law and Emerging Topics in Family Law Learning Objectives [Supports SLO # 1, 2, 5]

#### The student will be able to...

- Explain the role of alternative dispute resolution (ADR), and how mediation is used in family law
- Explain the role of the state courts and administrative agencies in family law.
- Discuss the practical role and responsibilities of the family law paralegal within a variety of legal employment settings.
- Draft a case brief for a landmark case of significant historical value.
- Locate, discuss, and analyze prominent family cases and/or news articles.
- Discuss the practical role and responsibilities of the family law paralegal within a variety of legal employment settings.

# Unit III The Law of Divorce Learning Objectives [Supports SLO # 1, 3, 5] The student will be able to...

- Observe a client intake interview and/or initial client interview, and provide the appropriate documentation as assigned, from the perspective of a non-lawyer.
- Read an initial draft of a divorce complaint from the perspective of a non-lawyer
- Work with a hypothetical file over a period of many course weeks, with progressive responsibilities and duties, from the perspective of a non-lawyer.
- Locate, analyze and discuss news articles and/or prominent cases in the area of family law from the perspective of a non-lawyer.
- Describe the paralegal's role when working with divorce cases including research and accessing document templates via state government websites.

# Unit IV The Law of Child Custody, Adoption & Child Support Learning Objectives [Supports Course SLO # 3, 4] The student will be able to...

- Discuss the principles of child custody, child support and adoption.
- Describe the paralegal's role when working with cases concerning child support including research using public-facing state government websites and formulas.
- Analyze a hypothetical practical legal task and determine the appropriate next steps to complete the task.
- Apply best practices to draft documents used in child support, child custody and/or adoption.
- Describe the process of draft review, revision and editing to ensure content accuracy in legal documents.

#### **Evaluation of student learning:**

**Assignments:** Written research assignments, legal document drafting assignments and practical legal tasks designed to assess preparedness for practical legal writing and research work.

**Quizzes:** Essay, mechanics and grammar writing exercises and multiple-choice assessments designed to measure understanding of objective legal research and writing concepts.

**Discussions**: Course-related conversations in a live setting or via discussion board to support and assess concepts presented in the unit.
